Collection and use of Cookies on the Dogs for Good website

1. What are Cookies?

A cookie is a small file which is sent from our website to your computer (or mobile or tablet) to help us recognise it quickly. Cookies allow websites to respond to you as an individual. The website can tailor its operations to your needs, likes and dislikes by gathering and remembering information about your preferences. Cookies also help to analyse website traffic.

2. Why do we use Cookies?
