

Dogs for Good Gala Dinner 2025 – Thursday 3rd April

Terms & Conditions

An online registration constitutes a legally binding agreement with Dogs for Good and so we recommend that you only register once you are sure of your attendance. Dogs for Good is unable to issue refunds if you are no longer able to attend the event.

- Without exception, all bookings must be paid in advance prior to attending the event.
- All delegates must be registered via the online booking system or have your booking confirmed by email from the conference support team.
- Dogs for Good have implemented an online payment system to allow payment by credit/debit card. Guests who prefer to be invoiced should confirm this at the point of registration (and note the invoice payment terms are only available up to Thursday, 20th March 2025). All invoices should be paid directly to the account details displayed on the invoice.
- The venue is cashless, and any purchases made on the night will need to be made via card.
- The payment terms of Dogs for Good invoices are 14 days, and all invoices must be paid before Thursday, 20th March 2025.
- From 11.59pm on Thursday, 20th March 2025, the option to pay by invoice will be removed. Only immediate payment by credit card will be accepted.
- Dogs for Good reserves the right to cancel any event places where payment has not been received.

Pricing

- All event fees, including any sponsorship arrangements that are part of your dinner package, must be paid in full prior to the event.
- Individual tickets are priced at £110 each.
- A table of ten is priced at £1,100, which includes a drinks package, seating together, and a premium position in the room (subject to availability).
- Friends & Family discount is available for staff, volunteers and clients. And is valid for individual ticket purchases only. A maximum of six tickets can be purchased with the discount in one transaction.

Amendments

- All amendments must be made in writing via the conference support team at dogsforgood@conferencecare.com
- Although substitutions may be accepted if notified in writing prior to the event (as set out above), we cannot guarantee that dietary and access requirements will be met.

Liability

- Dogs for Good accepts no liability to event attendees, except as set out in these Terms and Conditions, and we are unable to accept liability for the loss of your personal property while at the event.

International Bookings

- Dogs for Good is unable to provide any international delegates with visa information and can only provide a letter of invitation to assist in this process. It will be the attendees own responsibility for arranging their own visa.
- Dogs for Good are unable to assist with booking any travel arrangements for international attendees.

Event Dinner

- All dietary requirements will be met if disclosed at the time of booking. We cannot guarantee that any dietary requests, on the evening of the event, will be met if the events team were not made aware at the time of booking.
- The individual ticket price includes still water. It does not include any alcoholic beverages.
- Table bookings include a drinks package of five bottles of wine for the table and guests can purchase additional beverages on the night.
- We are unable to guarantee the seating together of individual tickets that are purchased separately. Table bookings ensure that groups of ten guests can be seated together.
